

# Toroa International Postgraduate Fee Scholarships

## Scholarship Regulations

### Focus

International Students

### Level of Study

Postgraduate

### Purpose

The Toroa International Postgraduate Fee Scholarship supports international students to study at Massey University, in alignment with Massey's diversification strategy and the goal of attracting students from diverse markets.

### Value and Tenure

The value of the scholarship is NZ\$5,000 towards the tuition fee, the tenure is one year.

### Typical Number on Offer

Up to 80 scholarships are available annually.

### Eligibility

Applicants must be international students who are new to Massey University and intending to enrol, full time, in their first 120 credits of one of the following postgraduate degrees in the year of award:

- Master of Analytics
- Master of Applied Social Work
- Master of Business Administration
- Master of Business Studies
- Master of Construction
- Master of Finance
- Master of Information Sciences
- Master of Management
- Master of Professional Accountancy

- Master of Professional Accountancy (Chartered Accountant)

## **Selection Criteria**

The selection will be based on the applicant's proposed contribution to a vibrant Massey campus.

Consideration of personal characteristics including country of residence will be given to ensure equitable awarding.

## **Selection Committee**

The scholarship is awarded by the University Scholarships Selection Committee.

## **Conditions of the Scholarship**

To be eligible for this fee scholarship, students must have received an Admission Offer of Place into a full-time postgraduate degree commencing in Semester 1 (February) 2027.

Recipients are required to pay the first-year full fees, or a NZ\$500 contribution towards the tuition fees, within 2 weeks of the scholarship award in order to secure the scholarship. Failure to make this payment by the due date will result in the scholarship offer being rescinded.

Recipients will have met academic entry and meet the English requirements for admission into their chosen programme of study at Massey University.

Applicants must be international fee payers only to be eligible for this scholarship. This fee scholarship is not open to Australian or New Zealand citizens or permanent residents of Australia or New Zealand.

Applicants must not have already started a degree at Massey University at the time of application for the award.

This fee scholarship may be held with other scholarships but cannot be held with International Study Grants or Fee Discounts.

Applicants who are already enrolled in a Massey University partner institution's TNE or articulation programme are not eligible for this award.

Applicants must be willing to participate and cooperate in marketing and communications activities (Scholarship Commitments) for their Faculty/Massey University. This may include testimonials and public relations opportunities, as well as being involved in and attending Open Events, Webinars or being a class representative.

Fee scholarships are not transferable or deferrable. They are valid only for use by scholarship winners in the academic semester for which they have been awarded. Scholarships cannot be deferred.

Recipients must remain enrolled in the approved programme of study in order to receive the full scholarship.

If awarded, the fee scholarship will be paid into the student's Massey Fee Account after the census date (last date of withdrawal without financial penalty)

Should the recipient withdraw from study in the first year, the scholarship will be withheld from any refunds.

A full refund of NZD \$500 will be issued where a Toroa recipient is unable to obtain a valid Student Visa to undertake study in New Zealand, subject to the provision of satisfactory evidence of the visa decline.
